I am a citizen of Utah and am very concerned about the energy corridor draft plan.

First, it is not clear that all the proposed corridors are needed. And second, it does not seem necessary that they go through some of the most scenic areas in Utah. These areas have great value as places to enjoy wilderness for Utahns and attract many visitors from abroad. Value in terms of dollars spent on recreation will only increase with time if places are kept beautiful.

As my husband and I have spent much time enjoying the spectacular scenery and back country of Southern Utah, we were particularly dismayed to see the following places listed as proposed corridors:

1. Glenn Canyon is a gem, and much of it is not yet damaged by humans.
2. Paria Canyon and Buckskin Mountain are absolutely stunning, and one of our favorite places to backpack.
3. My entire out-of-state family was smitten by the beauty on a river trip below Flaming Gorge Dam.
4. Dead Horse pass is another gorgeous vista.
5. Views from Arches are some of the best known in the world and attract thousands of paying tourists. A view of a swath of transmission lines cutting across the landscape will greatly diminish the esthetic value.
6. And finally on a devastating personal note, we recently purchased land adjoining Grand Staircase and Upper Kanab Creek. We purchased it for the view of the white and pink cliffs and the natural wonders of the nearby Monument. It appears that both will be degraded if the proposed corridors are approved.

So, we respectfully urge you to consider the unparalleled and irreplaceable value of wild areas for state residents, US citizens and foreign tourists. Thank you very much.
